If you want to go to a safe place we arrange it for you. We also arranged for Desmond to leave the country. Because at that time 1989 we got report on the negotiations but as a army we still need to be prepared it was only in 1991 that there a call for MK to stop all military activities. But we stopped all activities in mid 1990 we stopped operations but we had to keep things in tacked our units and our ammunition. I think we had ammunition until 1994.

Coming back to Mitchell's Plain we had this contradiction there we had to on the record guys explaining they went on operations and when they got there the police was there already. They went on another operation and then explosives would disappear and it was that point and time that we decided that we are going to cut all ties with Mitchell's Plain we are not going to have any operations there but we are going work on the individual commander there and try to get our material out of the are and tried to find who is the person that is busy with dirty tricks. But they were not really cooperating. But we it is contradicting is that Desmond Mackenzie where he was order into the underground he decided that one point he can't take it anymore and that he is going home. So if you know that you are wanted but the cops don't come to you we just put question marks. The cops was still looking for me and Reiveldt was under section 29.

Then we submitted a report we explained Desmonds position and Andre from Mitchell's Plain and we thought lets get them out of Cape Town. Then Andre submitted under MK and he was accepted under CPR and Desmond but they were dismissed from the army in 1990. In our report when I looked at the CPR report in 1995 I have discovered a list of names, people from Mitchell's Plain that are saying that they were part of the Ashley Kriel detachment, but we had no profiles of these people. There was one Errol April but we never recruited Errol April. But we don't know where the lies started. Up to know Reiveldt submitted reports and Desmond and he wrote a letter to Dullah Omar to clear himself. So that was the sore point Mitchell's Plain.

Zenzile:

Was there a case in Mitchell's Plain where a person was found with weapons but the case was never prosecuted in court.

Bruintjies:

We were looking for an AK and a Macrov and this guy Shane Oliver...Shane Oliver was part of our unit. But they are claiming that Shane was part of Military Intelligence but it is not on record for me and I don't know it. Up till today I will be happy if Desmond would come to me and say this is it. I have submitted this report and there is people now that must work through this report. I want to meet with Ian and Shane Oliver. I have never met him up today. Desmond and Reiveldt was entrusted with a lot of ammunition and they had to supply the Boland region.

Zenzile:

So what happened to Reiveldt when they arrested him.

Bruintjies:

There was a Section 29 and he went to court and then he was indemnified.

Zenzile:

Did you ever hear of the name Ashwell Sampson.

Bruintjies:

No, I don't know the name.

Zenzile:

Let me put you in the picture Ashwell Sampson is an operator from Directorate Covert Collection currently located at the rank of Sergeant Major at Youngsfield but he was doing collection in the Athlone, Mitchell's Plain area operating out of Grassy Park. Which would been crossing wires with your unit because that was his task to penetrate that areas. I think Melvin that you have been very cooperative and helpful, I will from the side of the commission follow up the lead that you have put before us with the eye of clarifying some issues and maybe getting some answers because I can see that you certain things are bothering you. But we will try our best and maybe come up with a report if anything comes up please call me.

Bruintjies:

I am prepared to meet with Joffrey in this context to avoid that thing of you phoning him and him saying things. Because I feel it is time that these families, see Mrs. Williams somebody has given her new hope that something was going to come out.

Zenzile:

What I can say is this for the purpose of the investigations please do not contact him for about three weeks.

Bruintjies:

I have no intention of contacting him.

Zenzile:

Thanks Melvin.

# STEENKAMP INTERVIEW - TAPE 1 BY ZENZILE KHOISAN (0010017) AND MOHAMMED MULLER

WE ARE SPEAKING TODAY WITH STONE STEENKAMP AT THE ANTI-CORRUPTION UNIT IN THE SOUTH AFRICAN POLICE SERVICE.

ZENZILE:

MR STEENKAMP, COULD YOU GIVE US YOUR FULL RANK AND HOW DO

YOU WANT TO BE ADDRESSED?

MR STEENKAMP:

I AM CAPTAIN AJ STEENKAMP. YOU CAN CALL ME STONEY OR

STEENKAMP, IT DOESN'T MATTER. THEY NORMALLY CALL ME STONEY.

ZENZILE:

IN TERMS OF THIS PARTICULAR CASE THAT WE ARE CURRENTLY LOOKING

AT, YOU CONFIRMED AN EVENT WHICH OCCURRED IN JULY 1989, TO BE EXACT, I BELIEVE ITS JULY 26, 1989. IT INVOLVES AN EXPLOSION WHICH TOOK PLACE AT ATHLONE IN WHICH TWO PEOPLE WERE KILLED, NAMELY, COLLIN WILLIAMS AND ROBERT WATERWICH. THE EXPLOSION RESULTED IN THESE TWO PEOPLE'S DEATH AND THE INCIDENT WAS ESSENTIALLY INVESTIGATED BY THE THEN SECURITY POLICE. AT THAT TIME YOU WERE A MEMBER OF THE SECURITY

POLICE.

STONEY:

YES, THAT'S CORRECT, I WAS WITH THE INVESTIGATING TEAM.

ZENZILE:

WHAT WAS YOUR RANK AT THAT TIME?

STONEY:

WARRANT OFFICER.

ZENZILE:

THE LOG FOR THAT TIME INDICATE THAT YOU WERE PRESENT AT THE SCENE

AND THE COMMUNICATION INDICATES THAT YOU HAD A ROLE IN THE

INVESTIGATION, IS THAT TRUE?

STONEY:

I CAN'T RECALL THAT I WAS AT THE SCENE, YOU MUST REMEMBER THERE WAS ANOTHER STEENKAMP TOO, I WAS CALLED "KLEIN STONEY" AND HE WAS CALLED "BIG STONEY". HE WAS A SERGEANT AND COULD HAVE BEEN AT THE SCENE

BECAUSE I REALLY CAN'T RECALL BEING AT THE SCENE.

ZENZILE:

IN TERMS OF THIS PARTICULAR SCENE - THE PEOPLE THAT WE HAVE SPOKEN TO, AND THE REASON WHY WE CAME TO SPEAK TO YOU LITERALLY, IT'S BECAUSE FOR US WHAT IS IMPORTANT IS FOR US TO BE TOLD WHAT OCCURED. THE FACT THAT THESE TWO PEOPLE WERE MEMBERS OF A RESISTANCE MOVEMENT AND THAT THEY DIED. THE ISSUE HERE IS TO ESTABLISH THE CONDITIONS UNDERWHICH THEY DIED AND PEOPLE HAVE TOLD US THAT YOU WOULD HAVE INFORMATION RELATED TO THE FORENSIC PART OF IT, WHICH ESSENTIALLY INVOLVES THE INVESTIGATION. AS YOU INDICATED THAT YOU WERE PART OF THE SECURITY POLICE INVESTIGATION TEAM, THAT, INFACT HAS BEEN CONFIRMED BY YOUR COLLEAGUES, PEOPLE WHO WERE PART OF THE BOMB DISPOSAL SQUAD. SENIOR SUPERINDENT DU PLESSIS WAS ALSO PART OF THAT.

STONEY:

YOU SEE WHY THEY CAN'T ACTUALLY PLACE ME ON THE SCENE IS THAT I KNOW THAT THEY TOLD ME THAT THERE WAS A MINI LIMPET ON THE SCENE AND THAT IT SEEMS TO ME THAT FROM WHAT I HEARD THAT THERE WAS SOMETHING WRONG WITH THE TIME DEVICE AND THAT IS WHY IT EXPLODED, WHEN THEY PULLED OUT THE PIN THERE WAS NO SAFETY CATCH AND IT WENT STRAIGHT THROUGH, IT COULD HAPPEN BECAUSE IT WAS VERY LOOSE. I KNOW THAT GROOT STONEY WAS ON THE SCENE AND NOT ME. THOSE THINGS WERE TOLD TO ME. IT COULD BE THAT THEY TOOK SOME OF THE FORENSIC FOUND ON THE SCENE TO PRETORIA. I WAS NOT INVOLVED IN THAT INVESTIGATION.

ZENZILE:

DO YOU RECOGNISE THIS PICTURES? FOR THE RECORD JUST LETS.... PHOTO ALBUM - "ONPLOFFING ATHLONE MR2640789189, 1989, 23, 21H12", LOWER KLIPFONTEIN ROAD". DO YOU RECOGNISE THESE PICTURES? PICTURES 1-20.

STONEY:

I HAVE BEEN ON A LOT OF SCENES, NO I WAS NOT ON THIS ONE, DEFINETELY.

BECAUSE YOU KNOW GETTING ON A SCENE LIKE THIS REALLY MAKE AN IMPRESSION ON ONE. I COULD REMEMBER CLEARLY THAT THERE WAS LIKE IN BISHOP LAVIS WHERE A BLOKE PICKED UP A LIMPET MINE THAT WAS IN A "HOUT BOX, IT WAS AT THE SCENE WHERE THAT BLOKE SHOT IN THE HOUSE... ERRR... WHAT WAS HIS NAME? EHRR...

ZENZILE:

ANTON FRANCSH.

STONEY:

ANTON FRANSCH. I DID THE SCENE THERE EHRR... THERE WAS A LOT OF PEOPLE WHO WERE INJURED. I COULD RECALL ALL INCIDENTS. BUT THIS ONE I CAN'T. ESPECIALLY, YOU KNOW WHEN YOU ARE LOOKING AT LIKE, FOR EXAMPLE, THERE IS A FOOT ON THAT STAIR THERE, THOSE THINGS DO MAKE AN IMPRESSION ON ONE. IT DOESN'T MATTER AFTER HOW LONG A TIME. I WOULD RECALL SUCH A SCENE. I CAN REMEMBER ALL THE SCENES WHERE I HAD BEEN. THAT IS WHY I AM SAYING I WAS NOT AT THE SCENE BECAUSE I WOULD RECALL IT IMMEDIATELY.

ZENZILE:

YOU OF COURSE, WERE PART OF THE INVESTIGATING TEAM. DO YOU RECALL TAKING ANY FORENSIC EXHIBITS OR EVIDENCE FOR TEST TO PRETORIA OR SOME PLACE UP NORTH?

STONEY:

I CAN'T RECALL. AS I SAY I HAVE BEEN TO PRETORIA A LOT OF TIMES. IT COULD BE THAT I ..... I TOOK SOME STATEMENT OR DOCKET AND BECAUSE TO ...... AND THERE WILL BE INVESTIGATING AND THE OFFICER HIMSELF WILL SAY TO ME ...???

MOHAMMED:

ON THE QUESTION OF THE TIMING DEVICE YOU JUST MENTIONED A FEW MINUTES AGO AS TO WHAT HAPPENED. THAT YOU HAVE BEEN TOLD BY ONE OF YOUR COLLEAGUES THAT ... FROM THE SPECIFIC TIMING DEVICE WERE OUT.

STONEY:

IT COULD HAPPEN THAT SOMETHING LIKE THIS AND THERE IS A PIN HERE AND A PIN THERE AND THE LID COULD HAVE BEEN PULLED OUT BECAUSE THAT THING IS VERY LOOSE. THAT IS WHY NORMALLY THEY PLACE IT UP SO IF THAT LID IS GONE... BECAUSE OF THAT THING THERE YOU GET DIFFERENT ... OF LIDS. IF THE LID IS GONE THAT SPRING GOES IMMEDIATELY DOWN.

MOHAMMED:

PARTICULAR TO THIS, THE FORENSIC, WERE THE PEOPLE THAT WERE EXACTLY ON THE SCENE TAKING ANY PARTICLES, LIKE IF, THE LIMPET EXPLODED, OF COURSE, THERE ARE CERTAIN PARTICLES LIKE FRAGMENTS IT LEAVES BEHIND. IN ORDER TO ESTABLISH WHAT KIND OF EXPLOSIVES WERE USED, HAS THE FORENSIC SEND IT FOR TEST OR WHATEVER.

STONEY:

WHAT ACTUALLY HAPPENED ALL THE TIME IS THAT WE FROM THE BOMB EXPLOSIVE UNIT, ITS NOT NECESSARY FOR US TO SEND SOME EXHIBITS TO PRETORIA, ONLY WHEN WE ARE NOT CERTAIN ABOUT WHAT KIND OF EXPLOSIVE WAS USED, 'DAN SAL ONS SMERE NEEM', AND THEN WE SEND IT TO ESTABLISH WHAT KIND OF EXPLOSION IT IS.

ZENZILE:

YOU WORKED WITH A BOMB DISPOSAL SQUAD AT THAT TIME. THE GUYS WHO WERE WORKING WITH YOU INCLUDE NOW SENIOR SUPERINTENDED DU PLESSIS, ETC. AND YOU USED TO HOLD LIKE DISCUSSION OR RATHER THERE WAS CONSTANT REVIEW OF CASES, ESPECIALLY THIS CASE, BECAUSE IT PROVOKED QUITE AN OUTCRY IN THE COMMUNITY. ESPECIALLY IN TERMS OF THE WAY THEY WERE KILLED. ON THAT DAY THERE WERE SOME OTHER

EXPLOSIONS TOO, IN THAT SAME TIME FRAME, TWO OR THREE. THERE WAS A COLLECTIVE STRATEGY OF HOW TO LOOK AT THIS. WHEN WE BEGAN THIS DISCUSSION YOU BEGAN BY SAYING THAT THIS WAS A MINI LIMPET THAT HAD EXPLODED. WAS THIS THE OFFICIAL THINKING OR WAS IT YOUR OWN VIEW?

STONEY:

I CAN'T REMEMBER, IT COULD HAVE BEEN A LIMPET OR IT COULD BE EHRR... BUT IN MY OWN MIND I ALWAYS... IF YOU ARE TALKING ABOUT .... THEY DID HANDLE MINI LIMPETS. IT COULD BE THAT IT WAS A BIG ONE, BUT IT STUCK IN MY MIND THAT I WAS ALWAYS UNDER THE IMPRESSION UP TO NOW THAT IT WAS A MINI LIMPET.

ZENZILE:

IN TERMS OF THAT. WHEN THEY CAME TO THAT CRIME SCENE, I TALKED TO THE GUYS AT ATHLONE, WHICH I S THE NEAREST POLICE STATION. THE POLICE OFFICERS AND THE DETECTIVES FROM ATHLONE WERE ON THE SCENE BUT VERY SHORTLY AFTER THAT EXPLOSION THE SCENE WAS CODENED OFF AND THEY WERE REMOVED FROM THE ACTIVE INVESTIGATION. AND ONLY THE POLICE WERE INVOLVED.

STONEY:

JA, THAT IS A NORMAL PROCEDURE.

ZENZILE:

NOW ON SITE THERE MUST HAVE AN EVALUATION OF WHETHER THIS WAS A GRENADE, OR THIS WAS A LIMPET MINE AND PART OF THE INVESTIGATION WOULD ALSO BE TO SEE HOW YOU COULD GET TO OTHER GUYS. YOU WERE PART OF THE SECURITY POLICE, YOURSELF, LIEBENBERG, ETC. THE THING THAT YOU HAD TO DO AT THAT TIME WAS TO TRY AND FIND OUT AS QUICKLY AS POSSIBLE, WHO WAS INVOLVED, WHO WAS INVOLVED? MAYBE YOU COULD TRY TO SEE WHERE THIS CAME FROM, WHICH CELL THEY WERE CONNECTED TO. ALL OF THOSE WOULD HAVE FORMED PART OF THE NORMAL INVESTIGATION. NOW ON YOUR SIDE THE GUYS ARE MOSTLY TALKING ABOUT YOU. AND YOU HAVE TO REALISE FOR US DECODING THIS CASE IS REALLY A CASE OF A COMBATANT WHO DIED. TO BE VERY CLEAR. IF HE WAS SOMEBODY WHO WAS A KNOWN ACTIVIST IN THE AREA, IF HE HAD BEEN ARRESTED SOMETIME EARLIER AND DETAINED AT STEENBERG AND POLSMOOR RELATED TO THE FACT THAT HE WAS UNDER THE CHARGE OF .... ALSO THAT WAS PART OF THE PROBLEM THERE. THE BONTHEUWELS GUYS GIVING YOU PROBLEMS. THEY WERE A BIG PROBLEM FOR THE SECURITY.

SO TO SQUARE THINGS, TO MAKE THINGS, TO OPEN UP A WAY, BECAUSE YOU KNOW THE ONE THING IS THAT THE .... TALKS ABOUT THE MAKAROV, THIS THAT AND THE OTHER THING. BUT THERE IS NOTHING IN THE ... WHICH INDICATES ANYTHING ABOUT, YOU KNOW THERE IS NOT EVEN A FRAGMENT, THERE MUST BE SOMETHING.... THIS IS FROM ATHLONE, THIS COMES DIRECTLY OUT OF DU PLESSIS' OFFICE. THIS GOT REMOVED FROM CA'S LOOP STREET TO SOMERSET OFFICE.

A LOT OF ARGUING.... CAN'T HEAR CLEARLY.

WHAT HAPPENED IS THAT IN TERMS OF THIS INVESTIGATION, POLICE TOOK OVER THE INVESTIGATION, THEY WERE THE KEY MOVERS BEHIND THIS INVESTIGATION. THE ONLY THING THAT THEY HAVE AS A RECORD RELATING TO THEIR 13 AND THEIR 13 IN THEIR FILE, THE GUY FROM ATHLONE DID NOT INVESTIGATE THIS THING. THE ONLY REASON ITS GOT AN ATHLONE MR NUMBER IS THAT, THAT'S WHERE IT TOOK PLACE, AND THAT'S WHERE IT WAS FIRST REGISTERED IN THE OB. THE OB IN ATHLONE ...

STONEY:

THE 13 IS THE ONE THAT WAS KEPT AT CULENBORG. THEY HAVE GOT THEIR

OWN 13 AND THEY'VE THEIR OWN STORE THERE.

ZENZILE:

WHAT I AM SAYING IS THAT THERE IS A MAKOROV AND THERE IS SOMETHING ABOUT THE PANTY AND THERE IS SOMETHING ABOUT THE PAMPHLET THEY FOUND ON THEM. BUT THERE IS NOTHING TO DO WITH WHAT WE NEED. THE THING IS THAT WE NEED TO ESTABLISH FIRST OF ALL WHETHER THAT WAS A MINI LIMPET OR WHETHER IT COULD HAVE BEEN A GRENADE OR A BIG LIMPET.

STONEY:

WHILST I WAS IN PRETORIA - BUT NOW YOU ASKING ME IF THIS WAS THE SAME NUMBER - I HAVE BEEN INVESTIGATING .... FOR A LONG TIME. THE DOCKET WHERE IT WAS I DID NOT SEE ANY USE IN THAT THE PEOPLE TOOK DOCKETS AWAY FROM WHERE IT WAS. AS ALL THESE DOCKETS MUST HAVE BEEN AVAILABLE - BUT WITH ANY ...

ZENZILE:

THEY MOVED A LOT OF THINGS OUT OF 112 LOOP STREET.

STONEY:

JA, JA, THAT'S BRINGING A LOT OF HASSLES BECAUSE THE PERSON THAT DID THIS THING MUST HAVE PUT IN A STATEMENT. BECAUSE AFTERWARDS THERE WAS AN ENQUIRY ON THIS AND AT THAT STAGE THEY MUST HAVE ASKED FOR THE STATEMENT BECAUSE BOMB DISPOSAL OPERATOR WAS ON THE SCENE. BECAUSE THE NORMAL PROCEDURE ... AND HE COULD SAY WHAT WAS HIS

APPLIANCE ON THAT THING.

MOHAMMED:

ACCORDING TO YOUR PROFESSIONAL EXPERIENCE, LIKE YOU SAID, YOU WERE WORKING ALSO IN THE EXPLOSIVE DIVISION/BOMB DISPOSAL, ETC, THE PRACTICAL THEORY OF A MINI LIMPET IS .... IN AN AREA OF DESTRUCTION. CAN YOU GIVE ME MORE DETAILS ABOUT THAT?

STONEY:

YOU LOOK AT WHAT KIND OF DAMAGE THERE WAS. IS IT A BIG OR SMALL LIMPET MINE? THERE IS ACTUALLY MORE THAN A KILO OF EXPLOSIVES IN THAT AND A MINI LIMPET IS MUCH LESS. YOU CAN EXPECT THAT WHEN (CARRIES ON IN AFRIKAANS AND IS NOT CLEAR).

ZENZILE:

OK THERE WOULD HAVE BEEN TOTALLY DESTROYED.

STONEY:

NOW YOU HAVE BEEN ON MANY BOMB DISPOSAL SCENES, LETS LOOK IN THE PHOTO ALBUM LIKE ITEM 3 AND 5 PHOTO AND THEN LETS GO TO PHOTO 18 AND 19. PHOTO 18 AND 19 DEALS WITH THE POINT OF DETONATION AND PHOTOS 3 AND 5 IS THE DAMAGE TO THE BUILDING. NOW YOU KNOW ATHLONE VERY WELL. YOU KNOW EXACTLY WHERE THOSE PEOPLE WERE LYING AND YOU KNOW THAT TOILET IS LOCATED. DO YOU KNOW THAT TOILET?

STONEY:

NO I CAN'T RECALL THE SCENE. I HAVE TO GO THERE. AS I SAID I WAS'NT ON THE SCENE BECAUSE I WOULD DEFINITELY REMEMBER IT. SO I HAVE BEEN TO THE PLACE BUT TO REMBER THE EXACT PLACE, SAY, IN A BUILDING, THAT I CAN'T REMBER, EVEN NOW I CAN'T TELL YOU WHERE THE MAIN ENTRANCE IS, I KNOW

HOW TO GET THERE AND I KNOW WHERE THE BUILDING IS.

ZENZILE:

YOU SEE THAT'S THE DESTRUCTION TO THE WALL AND THESE ARE THE VICTIMS.

YOU SEE THE PROXIMITY OF THIS VICTM TO THE WALL. THESE ARE VICTIMS AND THAT'S THE WALL AND NOW IN YOUR MIND AS AN EXPLOSIVES EXPERT, IF THAT WAS A LIMPET MINE - THE DESTRUCTION RADIUS FROM WHERE THOSE VICTIMS WERE TO THAT WALL - DO YOU THINK THAT THE DAMAGE TO THAT WALL IS CONSISTENT WITH A LIMPET, A MINI LIMPET OR MAYBE A GRENADE?

STONEY:

I WILL SAY THIS IS A MINI LIMPET. IF I LOOK AT THE PERSONS HERE, THE BLACK HERE, THE WALL THERE, I WOULD SAY THIS LIMPET ITSELF WAS NT ACTUALLY NEXT TO THE WALL HERE, IT WAS A BIT AWAY, THAT'S WHY ALL THOSE .... MARKS DOWN THERE. BECAUSE WHENEVER ... LET ME SEE WHERE IS THE POINT OF DETONATION. IN NO WAY YOU COULD SEE WHERE THE THING WENT OFF, THE POINT OF DETONATION EXACTLY, AND NORMALLY A LIMPET MINE AND EVEN THE MINI LIMPET - YOU CAN SEE FROM THE MARKS ON THE GROUND HOW BIG IT WAS. NORMALLY THERE'S FOUR MAGNUS - WHEN IT'S HALF GROUND YOU WILL SEE THE MARK IT MAKES.

ZENZILE:

BUT THE DESTRUCTIVE RADIUS OF A BIG LIMPET STARTS MAYBE AT 20M AND IT SPREADS OUT MAYBE UP TO 65 THAT WOULD BE THE RADIUS THIS WAY. IT CAN GO UP TO 65 (NOT CLEAR) AND THEN ADD ON ANOTHER 45 OR ??? YOU HAVE DEALT WITH MINI LIMPETS BEFORE, WHAT WAS THE KILLING RANGE AND WHAT WAS THE...?

STONEY:

WITH LIMPETS YOU CAN'T EXACTLY SAY BECAUSE THERE ISN'T A LOT OF SCRAPNEL AND EVEN WITH THE BIG ONES TOO. THE ONLY SCRAPNEL THERE IS THE MAGNETS AND THE DETONATION ITSELF AND NORMALLY DISINTERGRATE BECAUSE OF THAT HIGH EXPLOSION THAT HAPPENS. WITH A MINI LIMPET IN NORMALLY DOESN'T .... A LOT EXCEPT FOR THOSE MAGNETS.YOU ONLY FIND THE MARKS AND YOU CAN ONLY ESTABLISH THAT THIS IS MUCH MORE THAN A HAND GRENADE AND LESS THAN A BIG LIMPET AS YOU LOOKING AT THE WHOLE SCENE AND TAKING EVERYTHING INTO CONSIDERATION.

ZENZILE:

THIS CASE WAS DISCUSSED. THE ISSUE OF THIS EXPLOTION WAS DISCUSSED AT CERTAIN MEETINGS.

STONEY:

I CAN REMEMBER THAT'S WHY I AM SAYING WHEN I AM THINKING OF THAT CASE I KNOW IT COULD I WAS THINKING OF A MINI LIMPET AT THAT STAGE.

ZENZILE:

WHO WAS THE MAIN GUY WHO WAS INVOLVED IN PUTTING THE THEORY OF WHAT HAPPENED?

STONEY:

ITS BOMB DISPOSAL PEOPLE AND EVEN YOU KNOW WHENEVER THEY SAY EXPLOTION OF SOMETHING HAPPENED, FOR EXAMPLE, THE INVESTIGATING TEAM AT CULENBORG, ONE DID THE INTELLIGENCE SIDE AND THE OTHER JUST LIKE ME AND JAN BLOM, WE WOULD HAVE INVESTIGATING OFFICERS, ALL WE DID IS GO STRAIGHT INTO INVESTIGATION, GETTING ALL THE VIEWS ON THE SCENE, STATEMENTS FROM WITNESSES AND THAT'S ALL. AND TRY TO GET TO SEE WHC THE ACCUSED IS.

ZENZILE:

WHEN YOU INVESTIGATED THIS WHO ARE THE KIND OF GUYS THAT YOU WOULD HAVE TALKED TO?

STONEY:

INVESTIGATING OFFICERS AND EVEN THE BOMB DISPOSAL PEOPLE BECAUSE THAT'S THE ONLY WAY...

ZENZILE:

DU PLESSIS, ETC, ETC.

STONEY:

YES, DU PLESSIS, ... STEMERS??, KARL VAN DER MERWE PERHAPS, THERE WAS A LOT OF GUYS AT THAT STAGE. I CAN'T RECALL THE NAMES BECAUSE LOTS OF PEOPLE ARE ACTUALLY GONE ALREADY. BUT THEN YOU DISCUSS BECAUSE OF THE NEXT YOU ARE DOING A FAMILIAR SCENE. YOU SEE THIS IS WHAT HAPPENED ON THAT ONE EEHR... THAT'S WHY I THINK YOU TOTALLY LOOKING FOR EVIDENCE... YOU SEE IN THE 13 YOU NORMALLY DON'T GET ANYTHING ... FROM A MINI LIMPET, FROM A BIG LIMPET YES, BECAUSE IT'S DOTANATOR IS ... LARGER AND NORMALLY IS SUCKED AWAY.... GET A SMALL STRIPS, SCREW DRIVES AND ALL THOSE THINGS.

ZENZILE:

DID YOU DISCUSS THESE CONSTANTLY WITH JAN BLOM AS YOU WERE

INVESTIGATING?

STONEY:

JA, WE HAVE ALWAYS. ALL THE INVESTIGATING OFFICERS WHEN WE ARE TOGETHER WE DISCUSS TO SAY, YOU KNOW, WHAT DO YOU THINK OF THAT, IS THERE ANY OTHER WITNESS? WE DISCUSS A CASE AFTERWARDS AND SO ON.

MOHAMMED:

LIKE YOU HAVE MENTIONED - THE QUESTION OF A MINI LIMPET - HAVE'NT GOT MUCH SCRAPNEL. SO ON THE QUESTION OF BLAST WAVE AND THE QUESTION OF FRAGMENTATION, I MEAN, HERE YOU SEE..., CUT OUT OF THIS WALL AND THIS IS BELIEVED BY THE POLICE EXPERTS, SO THAT SPECIFIC WALL THAT WAS PARTIALLY DESTROYED BY THAT EXPLOSIVE, SO I MEAN IF THIS THING HAVEN'T ANY SHRAPNEL, I DON'T BELIEVE THAT. BECAUSE THAT'S A CONSTANT WALL, I YOU ARE SPEAKING ABOUT A CONSTANT WALL. I MEAN YOU ARE SPEAKING ABOUT A CAVITY WALL THAT ARE BEING BUILT. TWO LAYERS OF BRICKS, I MEAN MYSELF I WAS DOING SOME KIND OF ... EXPLOSIVE. I HAVE GOT SOME KIND OF KNOWLEDGE, ESPECIALLY, ABOUT EXPLOSIVE. PARTICULARLY LOOKING AT TO THIS STUFF, YOU SPEAK ABOUT THE WINDOWS, THE BLAST WOULD HAVE OBVIOUSLY BROKEN THE WINDOWS. BUT SPEAKING ABOUT THIS, THERE IS NO... (INTERRUPTION).

STONEY:

JA, AS YOU SAID, OK, YOU KNOW, ESPECIALLY WHEN YOU ARE LOOKING JUST FROM THE PHOTO, THEY HAVE TAKEN OUT SOMETHING FROM HERE, SEEING THAT IT'S NEARBY, IT COULD BE THAT THE WALL ITSELF, THE CEMENT COULD BE A BIT LOOSE, I DON'T KNOW, IT'S HARD TO SAY WHEN LOOKING AT THIS. IN MY MIND I SAID THAT THIS IS SO FUNNY, YOU KNOW...(INTERRUPTION).

ZENZILE:

BUT YOU ALSO KNOW THAT A VIDEO EXIST IN THIS MATTER?

STONEY:

JA, NORMALLY KEEP SOME VIDEOS ON IT. THEY NORMALLY KEEP IT FOR A

WHILE. I HOPE IT IS STILL THERE.

ZENZILE:

NO, IT'S IN OUR POSITION.

ZENZILE:

WAS IT EVER DISCUSSED THAT MAYBE THAT DEVISE WHETHER IT WAS A GRENADE OR A MINI LIMPET OR WHATEVER, THAT IT MIGHT/MUST HAVE BEEN RIGGED? DID THAT ISSUE EVER COME UP. I MEAN, I KNOW THE SECURITY POLICE FOR DOING THEIR TASK AND IN TALKING TO MANY SECURITY POLICEMEN, ONE OF THE THINGS THAT I FIND IS THAT THEY WERE INVESTIGATING CASES AND WORKING ON FILES AND THEY WERE NOT DIRECTLY INVOLVED IN PHYSICALLY DEALING WITH SOME OF THE OTHER DIRTY WORK. LIKE YOU WERE PART OF THE

INVESTIGATION, YOU WER LOOKING FOR SO AND SO, YOU WERE LOOKING FOR TONY YENGENI, YOU WERE LOOKING CHARLES JACKSON, ETC. DO YOU

REMEMBER THAT GUY?

STONEY:

JA, CHARLES JACKSON, I REMEMBER HE WAS.... DID'NT HE WENT OUT TO AUSTRALIA OR SOMETHING.

ZENZILE:

I WANT TO SAY, FOR INSTANCE, YOU WERE WORKING ON FOLLOWING UP ON PEOPLE IN CASES, NOW GUYS FROM DIRECTORATE COVERT COLLECTIONS (DCC), THEY HAVE THEIR OWN AGENDA.

STONEY:

.... I WAS ON MANY SCENES EVEN ON THAT EARLY LEARNING CENTRE AND SAID TO THEM THERE IS SOMETHING FUNNY GOING ON, AND I .... THEY GAVE ME A WRONG FLAT NUMBER, THEY SAID FLAT 2 NUMBER 5 MEANTIME IT'S FLAT 5 NUMBER 2, YOU KNOW THEY CHANGED THE NUMBERS AND AT SOME OF THE SCENES I WOULD FIND THAT THIS SOME OTHER .... NOT THE NORMAL SCENE.

ZENZILE:

ONE OF THE THINGS THAT HAVE COME UP, WE HAD THE CRAZY THING OF TRYING TO GO BACK IN HISTORY. WE DON'T HAVE SOMETHING LIKE IT HAPPENED TODAY, TOMORROW WE CAN BEGIN DECODING. WE DON'T HAVE THAT LUXURY. WE HAVE TO GO BACK AND DIG UP. AND IN DIGGING UP ONE OF THE THINGS THAT I HAVE FOUND IS THAT THERE WERE DIFFERENCES BETWEEN THE SECURITY POLICE, LIEBENBERG AND OTHER PEOPLE. THEY WERE INTERESTED IN SOLVING CERTAIN PROBLEMS, POLITICAL PROBLEMS, YES, BUT DCC, FOR INSTANCE, AND OTHER BRANCHES, YOU KNOW, MAYBE PEOPLE THAT WERE WORKING WITH JOOP JOUBERT, ETC, THEY HAD THEIR OWN PROJECT AND THESE PROJECTS WERE RUNNING CONCURRENT, SOMETIMES WIRES WOULD CROSS, LIKE FOR INSTANCE, THEY WOULDN'T LET YOU KNOW THAT THEY ARE WORKING FOR ... BUT YOU GUYS IN THE INVESTIGATION OF THIS CASE, I FOUND THAT THERE IS ONE THING THAT COME OUT IN TERMS OF THE SECURITY POLICE FILES LOOKING THROUGH PEOPLE WHO HAVE BEEN DETAINED, ETC. YOU KNOW ONE OF IT IS THE DCC, TONY WAS...DO YOU KNOW WHAT I MEAN. IN YOUR INVESTIGATION OF THIS CASE WAS THERE EVER A PROJECT THAT YOU THOUGHT MIGHT HAVE BEEN COOKED UP BY DCC? THAT THEY COULD HAVE ... YOU KNOW ...

STONEY:

YOU SEE WHAT HAPPENED IS THAT, ALTHOUGH, I WAS NOT INVOLVED IN INVESTIGATION OF THE CASE ITSELF. AS I SAID, WE TALKED A LOT, AND PEOPLE WOULD SAY, COLONEL/COLIN WE ... THE BLOKES NAME AND I SAID OK! THEIR NAMES ARE WELL KNOWN, AND IT DIDN'T COME AS A SURPRISE THAT THEY ARE INVOLVED IN SOMETHING LIKE THIS. ALTHOUGH, YOU KNOW, THAT THEY, YOU KNOW, I AM SPEAKING FOR MYSELF, AT THAT STAGE IT WASN'T FOR ME A SURPRISE THAT SOMETIMES YOU ACTUALLY .... A BLOKE WHO IS DANGEROUS, THEY ARE INVOLVED BUT YOU COULDN'T PROVE BUT YOU JUST HAD THAT GUTT FEELING. THEY MUST EHHRR.. IF SOMETHING LIKE THIS HAPPENS I WASN'T SURPRISED BUT NEVER AND I COULD TRULY SAY TO YOU THAT...

MOHAMMED:

COMING TO THE QUESTION OF, LIKE DIFFERENT AGENCIES AND DIFFERENT ORGANS, I WOULD JUST SAY THAT THEY WERE OPERATING ON THE QUESTION OF INVESTIGATING CERTAIN CASES, ETC. SO YOU SAY ACCORDING TO YOUR OWN EXPERIENCE THERE WAS SOMETHING WRONG GOING ON IN THAT PARTICULAR CASE OR OTHER CASES.

STONEY:

OTHER CASES, JA. BUT I CAN'T RECALL THAT SOMETHING WAS WRONG IN THIS

CASE BECAUSE I WASN'T INVOLVED IN IT DIRECTLY. THE ONLY THINGS I KNOW

ABOUT THIS CASE... (INTERRUPTED).

ZENZILE:

BUT NOW WE HAVE SQUARED SOMETHING HERE, WHAT'S THIS GUY'S NAME?

BLOM?

STONEY:

JA.

ZENZILE:

YOU HAVE WORKED WITH BLOM - WHAT WAS HIS FIRST NAME?

STONE:

JAN BLOM.

MOHAMMED:

SO, IN PARTICULAR TO CERTAIN CASES - YOU SUSPECT SOMETHING. WE LOOKED INTO OTHER ORGANS. WHILE YOU WERE CONDUCTING YOUR INVESTIGATION, WERE YOU ... WITH DIFFERENT AGENCIES, LIKE SAY, ARMY,

INTELLIGENCE, INTELLIGENCE MILITARY, INTELLIGENCE NAVY, ETC.

STONEY:

NO, I ONLY KNOW THAT THEY HAVE GOT THEIR OWN INFORMERS, BUT I NEVER DEALT WITH THEM, BECAUSE MY JOB IS AS INVESTIGATING OFFICER AND NOT THE INTELLIGENCE WORK. THEY WILL BRING THEIR INFORMATION TO ME, TO SAY, WE HAVE GOT SOME INFORMATION THAT, THAT BLOKE IS INVOLVED. SEE WHAT YOU CAN DO OR IF YOU CAN GET SOME MORE INFORMATION ABOUT HIM.

MOHAMMED:

OK. LIKE YOU SAID THEY BROUGHT INFORMATION TO YOU. TELL ME WAS THERE SOME KIND OF LIES IN?

STONEY:

JA, ACTUALLY, AFTER EACH EXPLOSIVE INCIDENT WE HAVE TO GIVE A FULL DETAIL REPORT TO THE PERSONS AND THAT INFORMATION WAS THEN DISTRIBUTED TO THE NECESSARY PEOPLE. I KNOW THAT PEOPLE WHO WOULD LIKE TO KNOW WHO IS INVOLVED AND THEN I MYSELF DIDN'T DO LIAISONS WITH THE OTHER UNITS.

MOHAMMED:

CAN YOU PERHARPS GIVE ME AN INDICATION OF SOMEONE THAT WAS DOING LIAISON AT THAT TIME?

STONEY:

YOU KNOW AS I SAID THIS HAS BEEN PUT ON A TAPE AND SENT TO HEAD OFFICE AND NOBODY SAID IF YOU FEEL THAT SOME OF THE INFORAMATION YOU HAVE GOT ..... DON'T NOTIFY BECAUSE WE WANT TO KEEP IT CLOSE FIRST. WE WILL LATER REVEAL IT. BUT THAT'S BEEN ... THE PEOPLE AT THE OFFICE, I DON'T KNOW WHO WAS THE .... AT THAT STAGE . IT WAS PURELY HIS DECISION OF HOW TO GET TO SOME OTHER PEOPLE. ALL HAD TO SAY WAS THAT, THIS IS THE INFORMATION I HAVE GOT AND THAT'S WHERE MY DUTY ACTUALLY STOPPED. THEN I STARTED TALKING TO PEOPLE TO GET INFORMATION ABOUT THE INCIDENCE I HAVE INVESTIGATED BUT I WASN'T INVOLVED.

ZENZILE:

TREVORS??? DID.

STONEY:

NO I WAS NEVER BEEN ON A TREVORS BEFORE, I KNOW ABOUT TREVORS AND THE PEOPLE WENT THERE TO DISCUSS AND THEY DISCUSSED THINGS. AND WHAT THEY DISCUSSED WAS NOT DISCUSSED WITH ME. I KNOW THAT PIET GOOSEN WENT ON A TREVORS, I KNOW THAT VIC WENT ON A TREVORS BUT THAT WAS A CO-ORDINATED THING WHERE INCIDENTS....(SIMULTENEOUS TALKING - NOT CLEAR).

ZENZILE:

WHAT I WANT TO FIND OUT IS A LOT OF STAFF WAS OPERATING OUT IN CULEMBERG, AND EVEN THE LOCAL STAFF WAS DISCUSSING CULEMBERG, YOU KNOW LIEBENBERG HAS ALREADY TOLD US. NOW WHAT I WANT TO SQUARE WITH YOU IS THAT YOU WERE ONE OF THE PEOPLE WHO WAS WORKING DIRECTLY IN INVESTIGATIONS. YOU KNOW THE COLIN CASE, COLEEN AND ROBY WERE NOT NOVICES. THEY WERE KNOWN TO THE SECURITY POLICE AS PEOPLE WHO YOU GUYS WERE LOOKING FOR.

STONEY:

JA. I KNOW THAT THEY WERE INVOLVED IN THE STRUGGLE.

ZENZILE:

PARTICULARLY SHE WAS WATCHED, FOR INSTANCE, YOU DEALT WITH THAT WHOLE ATHLONE, BELGRAVIA, BONTHEUWEL CORRIDOR.

STONEY:

JA, ACTUALLY...

ZENZILE:

SO, YOU WOULD HAVE DEALT WITH BELGRAVIA YOUTH CONGRESS, ETC?

STONEY:

THAT WAS ACTUALLY, IF I DEALT WITH IT, IT WAS NOT AS AN INVESTIGATING OFFICER. THAT WAS SAY, IN THE FIRST YEAR WHEN UDF WAS STARTED. AT THAT STAGE I WENT OVER TO THE INVESTIGATING TEAM. SO I KNOW THAT PEOPLE, YOU KNOW HAVE POWERS, OK WE WOULD CHECK ON WHAT THE MOVEMENT IS BUT SOME NAMES YOU KNOW, YOU KNOW THAT JOHNY ESSAU. YOU KNOW THAT THEY WERE WORKING ON JOHNY ESSAU BUT YOU HAVEN'T GOT THAT FIRST TIME KNOWLEDGE OF WHAT IS EXACTLY GOING ON EXCEPT WHEN THE CHARGE IS BEING LAID THEN THEY WILL GIVE THE DOCKET TO US, TO SAY, JOHNY DID THIS, INVESTIGATE IT NOW. OTHERWISE, OUR INVESTIGATING OFFICERS. WHAT THEY BROUGHT INTO THE WHOLE INTELLIGENCE SIDE OF IT. WE ONLY DO THE CRIMINAL CASES TO BE INVESTIGATED.

ZENZILE:

NOW IN JULY 1989 THE COUNTRY WAS ABOUT TO SHIFT OVER. THE PRESIDENT WAS ALREADY MAKING MOVES WITH MR MANDELA. THE WAS ALREADY, YOU KNOW, THE SECURITY POLICE STRUCTURES WERE BEING PREPARED FOR SOME KIND OF TRANSFORMATION PROCESS. THEY WERE ALREADY BEEN PREPARED PSYCHOLOGICALLY, LOOK HERE, THERE IS GOING TO BE A SHIFT, THERE IS THESE THINGS HAPPENING. EVEN THOUGH YOU CONTINUE YOUR WORK, YOU NEED TO FIND THIS ONE, THAT ONE AND THIS ONE, WHOEVER YOU CAN GET IN BEFORE THE WHOLE CHANGE OVER. 1989 WAS A HECTIC YEAR, IT WAS WHEN LOTS OF THINGS EXPLODED HERE. NOW YOU WERE WORKING ON THE INVESTIGATING SIDE - NOW WHO WAS DOING THE INTELLIGENT SIDE IN JULY '89? I AM TALKING ABOUT THESE KIND OF PERSONS, ESPECIALLY COLEEN, BECAUSE YOU HAVE GIVEN ME THE GUYS WHO WERE WORKING ON THE INVESTIGATING SIDE. WHO WAS DOING THE INTELLIGENCE SIDE? THIS WAS LIKE ONE SIDE OF THE SAME COIN, YOU KNEW EACH OTHER, IT WAS A VERY TIGHT FRATENITY, I MEAN I DO KNOW THAT YOU USED TO HANG OUT TOGETHER AND BRAAI.

STONEY:

JA, BECAUSE AT THAT STAGE PEOPLE WERE SEATING IN LOOP STREET AND OUR INVESTIGATING OFFICERS, COLONEL LIEB, BECAUSE THEY WERE THOSE PEOPLE YOU CAN'T DO ANYTHING YOURSELF. SO WHENEVER THERE IS SOMEBODY LIKE A SUSPECT TO BE ARRESTED THEN YOU TAKE LIEB WITH AND ALL THOSE PEOPLE THEY ARE THERE AND YOU ARREST THE BLOKE. SOME OF THEM THEY DID DO, LIKE, YOU COULD SAY THE INTELLIGENCE WORK INTO A DOCKET. I'VE GOT A DOCKET HERE AND MUST TRY TO GET MORE KNOWLEDGE ABOUT A

CERTAIN THING. COULD YOU FIND SOMETHING IN IT. BUT ON THE OTHER HAND LOOP STREET WAS SEATING WITH A MORE... PRISON SIDE, NOT ON THE DOCKET ITSELF BECAUSE THEY HAD THE INFORMATION ABOUT WHAT IS GOING TO HAPPEN, FOR INSTANCE, IF THERE IS AN ESCALATION IN THIS SIDE OF THING OR GOING DOWN OR THERE IS GOING TO BE ANOTHER MARCH, OR SOMETHING LIKE THAT. THERE SO MANY PEOPLE THAT PASS ME BECAUSE I WAS ACTUALLY ONE WHO WAS THE LONGEST IN THE SECURITY IN THAT PLACE UP TO NOW. AT NO STAGE DID THE INVESTIGATING OFFICER BEEN BROUGHT INTO A ROUND TABLE AND ALL THE INFORMATION THEY RECEIVE FREELY HANDED TO LIKE MYSELF.

ZENZILE:

WHAT YOU ARE SAYING TO SHORTEN THE QUESTION, YOU ARE SAYING THAT LIEBENBERG WOULD BE ONE OF THE MAIN GUYS WHO WOULD HAVE DONE THE INTELLIGENCE SIDE OF THINGS. I MEAN 1989 IS LIKE YESTERDAY, I MEAN.

STONEY:

JA, LIEB WAS LIKE WORKING CLOSELY TOGETHER WITH THE INVESTIGATING OFFICERS. WE WERE LIKE PEOPLE WHO WERE DOING THE HARD SIDE OF WORK, NOT THE INTELLIGENT SIDE.

ZENZILE:

I AM TRYING TO FIND OUT WHO WAS DOING THE INTELLIGENT SIDE?

STONEY:

IT COULD BE.., LET ME SEE, ANOTHER DP VAN ZYL WAS AT THAT STAGE. I MUST REMEMBER IF HE WAS ...., AAH! THERE IS REALLY A LOT OF PEOPLE, PIET GOOSEN. AT THAT STAGE COULDN'T THEY FIND A LIST OF ALL THE PEOPLE WHO WERE WORKING WITH THE SECURITY BRANCH BECAUSE IN THE INVESTIGATION TEAM WE WERE ABOUT SIX BLOKES, SEVEN AT THE MOST. THE OTHERS WERE ALL INVOLVED IN THE INTELLIGENCE SIDE. I WANT TO SEE IF THERE IS SOME NAMES, I DON'T KNOW WHEN JC COETZEE STARTED THERE. HE IS NOW ALSO A CAPTAIN. MEYER, HE STILL AT THE SECURITY BRANCH, THERE WAS ... CLOETE, I DON'T EXACTLY WHAT HE DID BUT THEY WERE PEOPLE THAT WERE INVOLVED, YOU MUST REMEMBER THAT SOME THREE OR FIVE BLOKES DID SOME INTELLIGENCE ON THE ANC SIDE AND THE OTHER ON THE PAC, OTHERS THE UNIVERSITIES. EVERYBODY HAS GOT A DIFFERENT EHRR....

ZENZILE:

I KNOW THE BREAKDOWN.

STONEY:

I WANT TO SEE, THERE WAS BURGESS, A LOT OF PEOPLE WENT AWAY, JANSE VAN RENSBERG, HE IS NOW IN ORGANISED CRIME HERE IN THE BOLAND. ANOTHER CAPTAIN MAREE HE WAS WORKING MORE ON THE AWB, THAT WAS HIS SPECIALITY. SUPERINTENDED VICTOR, HE WAS ALSO WORKING...

ZENZILE:

WHICH VICTOR WAS THAT?

STONEY:

VIKTER, HE WAS AT ONE STAGE HE WAS AT PRIORITY CRIMES IN KRUGERSDORP. THERE IS A LOT OF NAMES BUT SOME DIDN'T MAKE ANY SENSE BECAUSE THEY WERE JUST ADMINSTRATIVE. I THINK CAPTAIN LE ROUX, I DON'T KNOW WHAT POSITION HE WAS AT THAT STAGE. HE IS AT TOE??? COMMUNICATIONS PEOPLE HERE, YOU KNOW WHAT THE AFRIKAANS TOE IS. HE IS THERE NOW. I THINK TROMPIE WAS IN PAARL AND LOOP STREET. VAN RENSBERG, ... VAN ZYL EHRR...

ZENZILE:

YOU ALSO KNEW WHO WAS WHO IN TERMS OF LIKE WHETHER PEOPLE WERE...
THE WHOLE THING WITH ..... THAT YOU GUYS AT SOME POINT PUT.... IN
BELGRAVIA YOUTH CONGRESS SECURITY POLICE PENETRATED THAT
CONGRESS.

STONEY:

I DON'T KNOW WHO WAS THE SOURCE. THEY MUST HAVE SOURCES TO GET ALL

THAT INFORMATION.

ZENZILE:

TO BE VERY CLEAR I AM NOT TRYING TO... I AM JUST TRYING TO GIVE YOU A PICTURE. WE KNOW, FOR INSTANCE, THAT THE BELGRAVIA YOUTH CONGRESS WAS HEAVILY PENETRATED BY THE SECURITY POLICE AT THAT TIME AND THAT THEY WERE PAID SOURCES. BEFORE HAND WERE YOU AWARE THAT THIS BOMB EXPLOSION... YOU SEE YOU ARE AT THE POLICE STATION I MEAN. I AM SURE THAT BOMB MUST HAVE SHAKEN THE GUYS UP A LITTLE BIT. WOULD YOU HAVE HAD INFORMATION BEFORE HAND THAT THIS THING WAS GOING TO HAPPEN.

STONEY:

NO, I CAN'T RECALL ANYTHING. I WOULD HAVE BEEN TOLD THAT WE SUSPECT

SOMETHING. I DIDN'T KNOW ANYTHING ABOUT IT.

ZENZILE:

WHAT DID YOU INFORMANTS TELL YOU ABOUT THIS INCIDENTS BECAUSE YOU ALSO HAD A GROUPING OF PEOPLE THAT YOU WORK WITH HAD SOURCES,

WHAT DID THEY TELL ABOUT IT?

STONEY:

THERE WASN'T ACTUALLY ENOUGH TO HAVE SOURCES BECAUSE I WAS AWAY

FROM THE INTELLIGENCE SIDE I ONLY DID INVESTIGATION.

ZENZILE:

WHAT WERE YOU HEARING ABOUT, BECAUSE I AM SURE YOU WERE WORRYING ABOUT WHETHER THERE WAS ANYMORE WEAPONS IN THAT HOUSE, LIKE FOR EXAMPLES, AK 47s, GRANADES, LIMPETS, ETC. DID YOU HAVE ANY DISCUSSION

LIKE GOING TO RAID THAT HOUSE TO GET THE OTHER STUFF OUT?

STONEY:

I CAN'T EVEN REMEBER IF THEY EVEN WENT TO CHECK THE HOUSE OR WHICH HOUSE IT WAS. THEY WOULD HAVE NORMALLY HAVE DONE THAT THEMSELVES. IF I WAS WITH THEM, THEN NOTHING ACTUALLY DID HAPPEN AND I WAS OUTSIDE AND THERE WAS ENOUGH BLOKES AND...

ZENZILE:

WHERE IS THIS "BIG" STONE STEENKAMP NOW?

STONEY:

THEY HAVE BEEN TARGETED BY DIFFERENT KIND OF SECURITY POLICE OVER A PERIOD OF TIME. AND COLLEEN WAS PARTICULARLY TARGETED BECAUSE SHE WAS THE ONLY BIG SISTER OF THE WHOLE BONTEHEUWEL ACTIVISTS AND SHE WAS VERY RESPECTED. THAT'S WHY SHE WAS ARRESTED UNDER THE CHARGE OF KENDIS ..OM THE BOYCOT TO SORT OF LIKE MOTIVATE KIDS TO ENGAGE IN BOYCOTS, SO IF DCC WERE COLLECTING ON THIS LADY AND MAYBE GOT A SOURCE TO

PUT ..... EXPLOSIVES INTO HER HOUSE WHICH WAS THEN USED, IT WOULD BE

VERY IMPORTANT FOR US TO .... DO YOU SEE MY REASONING?

# Summary:

This case involves the death of a young woman activist from Bontehewel on or about 23 July 1989.

#### ACT 1

Coline Williams was a young woman who was politically active during the mid and late 1980s in Bontehewel and other areas in the greater Cape Town area. On 23 July 1989 she was killed, together with a political associate, Robbie Waterwich, after a limpet mine exploded at the public bathroom, near Kismet hardware on Lower Klipfontein road in Athlone.

#### ACT 2

The post mortem (2920/89), conducted at 08:35 on 25 July 1989, states the cause of death as "multiple injuries following an explosion." The then warrant officer D. L. Van Zyl of the then security police identified the body. The reason the body was identified by a member of the then security police and not by personnel from the Athlone Police Station is because the entire investigation into the events surrounding the incident had been placed under the control of the then security police. This has been confirmed by inspector Simpson of the Athlone detective branch who has stated that the local police and detective branch was only used to cordone off the area.

The victim's body was described by pathologist, Dr. Christer Gabriel Fosseus as "that of a severely traumatised adult female." (see appendix 1)

Other information which has emerged during the investigative process are as follows:

1) Coline Williams was an individual targetted by security police for surveilance and harrassment. Her detention on 30July 1986 at Steenberg Police station and later at Pollsmoor prison (11months) related directly to her political work, particularly among the youth. (see appendix 2)

2) Case 1158/86, Goodwood Court named the victim as Charged with the Following crime:

"Kinders aanhits tot boikot aksies."

3) It has been established from discussion, on and off the record with a person formerly employed with the Directorate of Covert Collection (DCC) that Coline Williams and Robbie Waterwich were part of a cell which had been placed under surveillance by DCC personnel and further that the limpet mine which is said to have killed the two activists may have been spiked by a DCC employee who had penetrated the cell. A senior official of the SAPS has informed the investigative unit that the forensic report concerning this particular incident needs to be closely scrutinised for inconsistencies.

## ACT 3

× - . \*

An inquest, conducted by magistrate Hoffmann (the same magistrate who conducted the Ashley Kriel inquest) on 28 May 1990 (appendix 3) found that the victim had died as a result of "'n ontploffing veroorsaak deur onuitkenbare springstof met gevolglike wydverspreide inwendige en uitwendige beserings."

#### Conclusion:

While the preliminary investigation has focussed on mainly on the incident in which the victim was killed, a deeper investigation into the activities into the role of the security establishment is currently being conducted to establish the circumstances and events which led to this young woman's untimely death.

SUBMISSION TO THE TRUTH AND RECONCILIATION COMMISSION FROM THE FORMER ASHLEY KRIEL MK DETACHMENT COMMANDER, ANEEZ SALIE 9 MAY 1997

The detachment respectfully informs the TRC of the following:

- 1) An bomb blast in Bonteheuwel in 1988, in which a civilian Moegamat Nurudien Bartlett, lost a leg, and for which the Bonteheuwel unit commander of our detachment is to seek amnesty. His application is attached to this report, and has our full backing and support. We deeply regret the injury, and plead that the civilian be compensated in full. Although the victim says he holds nothing against us, we nonetheless again beg his forgiveness.
- 2) Coline Williams and Robert Waterwich. We wish to confirm that both were fully-fledged members of our detachment. We do not know what went wrong during an official MK operation they conducted on July 23 1989 in Athlone in which they fell.

Based on our experiences with people of their high calibre in other areas, we can only assume that they had put their own lives at risk to save civilians.

By this we mean that the site where they fell was opposite the Athlone court and police station where they were meant to be, and that this could have come about because they were disturbed by the presence of civilians during the operation, and moved an already primed limpet across the road. They may have done so despite strict instructions not to do so.

We mention this possible scenario because another of our units had done precisely the same thing elsewhere, although thankfully they got away with it.

Coline and Robbie were both outstanding young people, who were prepared to make the ultimate sacrifice for their country. They were of the highest calibre, and would have had uppermost in their minds our policy of not hitting civilians under any circumstances.

We deeply regret their death and wish to apologise to their families and to our nation. We have been to the families, who support this submission, and although they are most forgiving, we hereby dedicate ourselves to helping to reconstruct and develop our country, as our way of making reparations.

We humbly and sincerely beg the families and our nation for forgiveness.

We request the TRC to consider the following:

- i) Both of them were on official MK duty for their country when they fell
- ii) Their families be fully compensated, as if they were official members of the security forces, because had a member of the security forces also fallen during that fateful operation, he/she would have been buried with full state and military honours, and their families and dependents would have been fully compensated. We ask exactly the same for Coline and Robbie.
- iv) This should be done not only because it is fair and just, but also because their families and dependents need the assistance.

#### 3) Anton Fransch

We wish to confirm that he was a fully-fledged member of our detachment, who was nilitarily trained in Angola.

We know from previous testimony to the TRC, and from our own sources, that he

was betrayed by a fellow MK member at the time, Mark Henry.

We reject Henry's testimony to the TRC that he had been forced to leave the place he had been staying with us because he feared for his safety due to our lack of discipline.

Nothing could be further from the truth. Our detachment was at its most organised, resourced and disciplined when he deserted us in early May 1989, because of his own lack of discipline, and because he appeared hellbent on turning his back on

MK and on returning to his family.

We did not inform on him to the police, as he implies. It would have been totally illogical to do so, because of the danger he represented to us. In fact, when we reported his desertion to our commanders in Botswana, we were commanded to take the strongest possible action to neutralise him, but we defied that order because at the time we did not think that that punishment fitted the crime.

The command felt he was of grave danger to us and them. Indeed, Anton, an

exceptionally member of our detachment, later died.

We wish to beg Anton's family and our nation's forgiveness for having lost him. His death, and Coline and Robbie's in particular, as well as every other casualty, fills us with agonising remorse and regret.

I doubt we will ever recover fully. Our commitment and opportunity to help build a

new South Africa is hopefully our way of dealing with the pain.

As with Coline and Robbie, we request that Anton's family and dependents be fully compensated, as would a member of the security forces who may have died at Anton's hands that fateful night.

Finally, we wish to ask the TRC to instruct us to do whatever it deems necessary to make up for having lost such fine, young people.

We respectfully and eagerly await your instructions.

## HAMBA KAHLE MK COMMANDERS COLINE AND ROBBIE

The People's Army Umkhonto We Sizwe dips its revolutionary banner in honour of two of its outstanding members in the Western Cape, Coline Williams and Robert Waterwhich. They were well trained, highly disciplined comrades, both at a political and military evel. They were irreplaceable forged in the furnace of struggle they made the ultimate sacrifice on July 23 at the Athlone Police Station and Magisterial Court. Their deaths underline yet again the high price we are prepared to pay for our liberation.

Comrade Coline Williams was recruited by MK in 1988 before the racists' October Municipal election, a period marked by severor repression. The racists had to deploy all available personpower at their disposal to make sure the elections happened, and as it happened hey were held under seige. Under these extreme conditions Comrade Coline was trained in Politics, Military Engineering (explosives) Military Combat Work and Firearms. She in turn trained others she recruited and commanded. During 1988 she successfully conducted hree operations involving limpet mines. Because of her commitment, dedication and ability she was elevated from the Bonteheuwel Zone Commander to the Athlone Area Commander in 1989. She thus commanded all the townships in the broader Athlone area (which includes Bonteheuwel).

Comrade Robbie was recruited a few months after Comrade Coline and received the same training as she did. Because of his ability ne was appointed the Commander of the Athlone Central Zone. He was totally prepared as well as very excited to conduct his first operation which was on July 23 in Athlone.

Given their training (which was the best to be had anywhere) and the fact that Comrade Coline was a veteran of three major operations nvolving limpets, the question obviously arises as to what went wrong on July 23.

We can safely discount the possibility that possibility that they made a mistake in priming the limpet. The procedure that they were trained in and which Comrade Coline successfully followed on three previous occasions, rules that out. It was virtually impossible for them to blow themselves up by mistake.

MK believes that one of the following two explanations apply:

First, they were interrupted by the enemy at the target. Once captured they were badly tortured (remember Maliti) but refused to speak Because they were badly mutilated as the result of the torture the enemy decided to execute them instead of having to answer awkward questions afterwards. It is precisely because of the possibility however slight- of interception that the Comrades were armed with a Makarov. But they probably did not get a chance to use it.

In addition, by making it seem that the two comrades had blown themselves up, the enemy also wanted MK to look incompetent. This would discourage further recruitment, they hoped. Needless to say they failed badly. Because even though cowards may flinch and traitors sneer, our militant and angry people were not easily fooled. The people and the army were strengthened too, by the outstanding courage of our fallen Comrades' parents. Their strength spurs us on to strike the final blow against the apartheid beast. We salute them.

The second possibility is that Comrades Coline and Robbie sacrificed their own lives to protect civilians. Being cadres of a special type, uppermost in their minds would have been the need to avoid civilian casualties and, at the same time, to spare the enemy no quarter as instructed by our Commander-in Chief, O.R. Tambo. Thus, it was possible that after months of reconnaissance at the target (the Athlone Police Station) they discovered, after priming and placing the limpet, that unexpectedly, there were civilians about. They probably decided to remove the primed limpet from the target, with the intention of returning it later. They must have been mindful of the incredible risk to themselves, yet they ere still prepared to make the ultimate sacrifice, such was their spirit of no surrender.

Because of their actions they have ensured that the hammer of the armed struggle and the anvil of the mass movement has stayed firmly in line. It was Commander Nelson Mandela, who 28 years ago at the launch of MK, said that between the hammer of the armed struggle and the anvil of the mass struggle that we will crush apartheid.

Since the early days of resistance the days of Cetshawayo through to Bambata- to the present, one undeniable feature has marked out revolution- our refusal to submit. It is in this light that we should view the martyrdom of our dear Comrades Coline and Robbie. They were inspired by the Ashley Kriels and the Ashley Forbes who in turn were inspired by those before them. Therein lies the guarantee of the successful execution of our revolution. No matter what blows we are dealt, we will no submit, we will fight.

Comrades, now is the time to pick up the spears of our fallen Comrades. Now is the time to strike the final blows at the heart of the apartheid beast.

## Basil Snayer at Garlandale High School interviewed by Zenzile Khoisan 0n 22 May 1997

Zenzile:

In terms of the investigation that we are dealing with for the record CT00306: Colleen Williams and also Robert Waterwhich which we are currently awaiting a statement. Basil you are knowledgeable about the event. Do you know the people who have been found to be victims by the TRC, namely, Colleen Williams and Robert Waterwhich?

Basil:

Of course, I know Robby , he was my wife's nephew, I know him very, very well. Through the association of the family. Basically, I know his career quite closely, which for started with him and a friend of his Robbie van Niekerk and others when they formed the SRC at the school which some SRCs were not recognised obviously during that period. We had gone through that process at the school. Both Robbies advised us on how to go about establishing one. They were successful in that and after that our relationship continued in terms of the political level. I didn't know Colleen at all. I came to know Colleen through Robbie together with Robbie. On the night that Robbie died, that every evening around 12h00 a certain Joffe came to visit me and I am not sure whether he first made a phone call, I think he did make an appointment to see me. He asked that I was ... investigation into the bomb blast. They hadn't known by then whether or not Robby and ... were involved. He made an appointment again to see me again in the next three weeks.... and a few other people, names of whom I am not certain. On two occasion he made an appointment to meet here at my school for the purpose of taking Joshlee ... to my mother-inlaw's house where Robby stayed. .... cache of arms, stacked somewhere in the house. The code that he needed to check out. This code is taken directly to the stuff ... and then we would have to remove the stuff. Until the following day we had made arrangement to park my car in such a way that I left the passenger side door open in the car park unlocked so that he could park his car to the left of my car and just look into my car. .. that had happened already, he came in a red Golf ... to go the house. After circling once or twice to make sure that we have not been followed we entered the house I liaised with my mother-in-law to explained to her now the reason

for our visit and she climbed into the ceiling and took out either two or three AK47s ... explosives, one or two hand grenades and then we scanned the rest of the house - Joffe decoded messages in the book pointed to the bathroom under the bath and we took out a blanket and Robbie's mother even went to put that into my car .... and we proceeded to the door where he transferred the staff same way as we got into the car.

Zenzile:

Do you know of Joffe before this particular incident?

Basil:

No, not at all.

Zenzile:

That was the first time that he met you?

Basil:

Yes.

Zenzile:

And he came and told you that he was coming on behalf of the ANC

underground?

Basil:

Ja.

Zenzile:

Subsequently, did you speak to any of the people in the command structure of Robbie and Colleen with regard to the incident?

Basil:

No, not until very recently when Hanif Sally? came to me. First, I got a telephone call from Mervyn Brentjies?? and he came to visit me with the idea of coming with a statement which they were.... from the family before the submission in the paper and asked certain questions. What I learnt from Hanif? is that Joffe did in fact not belonged to MK and to the political side of the movement. I didn't know how Joffe came to the operation. For me it is the demise that through the unit some instructions that filtered down to that level and he also told me that they were aware that Joffe had not handed over all that was found in the house in that they had certain suspicions about him which they wouldn't elaborate. So those are the only people in the Command Structures I spoke to subsequent to that.

This is quite recent.

Zenzile:

In terms of the family side are sure that this has been something that has been bugging the family for a long time and what on the side of the family have you found out about the incident or of the situation which occurred in and around that time?

Basil:

You see, I know that Robbie had spoken to me the Friday evening, he was busy with a paper on *The State of the Nation* for some..... or in whatever way he was going to be involved in this typing this on my typewriter at home and I remember he stayed there quite finished before he left for home. He said to me that he might be late on Sunday evening or he might not come at all, that I should phone his mother or his grandmother if in the .... and I started an investigation of our own going to find traces of .... everything we could lay our hands on. We believed that we could get hold of and realised that it was fairly dangerous. We had gone to... and no one could give us any answers.

Zenzile:

Do you know if there was a third person who was on the scene? Did that thing ever surface?

Basil:

No, but that was always our suspicion that there may have been the third or the fourth person. ..... and I held the view that somehow things went wrong through infiltration of some kind. We couldn't establish whether this was on the side of the cops or whatever side. ... our investigation.

Zenzile:

Did you ever know of a guy called Wesley who was involved with the Belgravia Youth.

Basil:

Yes, I knew Wesley very well.

Zenzile:

Do you think that he might be knowledgeable about this event?

Basil:

I think maybe Wesley is a good lead. He was also very young so I can't...dealing with young people myself I wasn't going to implicated Wesley in any sort of investigations around this case. He was to tricky, far too tricky.

Zenzile:

He was in the Belgravia Youth?

Basil:

Ja, he was a good friend of ours.

Zenzile:

Do you know his last?

Basil:

. . . . . .

Zenzile:

Did Hanif Sally? and Mervyn talk about who may have driven into the scene? Is that on a mission?

Basil:

No.

Zenzile:

According to them this was an operation which was sanctioned by the Command and under orders of ....?

Basil:

Ja, I know that information.

Zenzile:

And the mission was to bomb the Police Station and the Court.

Basil:

I have got the initial papers that they have given me. Their explanation of the case is contained in there.

Zenzile:

From your idea of the cell from which they were operating, what's your impression of the professionalism of that particular grouping?

Basil:

The impression that I got was that they were fairly pact?? and the reason I am saying so is that, if indeed the Unit was trapped that night, then the entire Unit would have gone up in smoke. But the fact that it was in terms of their Unit a once off thing and that the Unit itself was not in anyway affected except for the two casualties and it was able to continue its work effectively was for him proof that the operation went off fairly well according to plan and that the only thing in their submission, if you read that, that went wrong could have been similar to something that happened in Mitchell's Plain, the only difference is that people got away with it, and Colleen being aware of the stated aim of avoiding any civilian emergency

could have... when they realised that civilians were in the area, could have gone back and removed the limpet from its original place... to the toilet, and it was in that time that this happened.

I can't say I am .... about that particular ...especially in the light of what you told me now that .... considerations that the most likely place which civilians would go is not in fact the court, it was not in fact that side, but now it puts a new colour to the whole operation, ie, is the explanation of .... So in terms of the professionalism I can't really express an opinion about whether it was or was not very professional. I don't have enough information about whether or not the Unit stayed intact, or whether it was split or infiltrated.

Zenzile:

Just one further question. On the question Joffe - is it your view that according to the Commander that he was a part of this cell?

Basil:

I can only draw the conclusion that he couldn't have been central to the cell he must have been peripheral or not part of the military cell at all. From my knowledge about the case now Joffe could only have been an operative quite remote from the military operation and that he was in some way a courier or somebody connected to some other level of operation, possibly the political underground level and that certain members of the military unit used him to conclude the work. I can then also deny that perhaps that happened because from what Hanif told me, is that, political and military units were completely separate and therefore if the line of activity was diverted from military to the political. It also effectively diverts the attention from their particular unit. What puzzles me is that if that was the case why did the political unit also stay intact?

Zenzile:

That's the question that we have to somehow decode in the process of investigation. Basil I don't want to keep very much longer but I would like to come and speak to you maybe at your home next time if it's Ok with you.

#### STATEMENT

On the 30th July 1986 Coline was detained for 11 months at Pollsmoor Prison. Before being taken to Pollsmoor Prison she was taken to Steenberg police station for + - 6 weeks. During this time she was kept in solitary confinement. After this 6 weeks the family was informed that she was supposed to appear in Goodwood magistrate's court, but this never happened. After 6 weeks at Steenberg police station she was transferred to Pollsmoor Prison. What happened during this time we do not know. She was released from Pollsmoor Prison on 11 June 1987. She left home about 14h00 on the 23 July 1989, with a leather bag. She mentioned to quite a few people that she was being followed by Security Branch police in Mowbray late afternoon. She got my brother along the way who offered her a lift which she refused. Coline collected a friend, Vanessa November. When she left home she had sanitary towels, tissues in a brown bag in her leather bag. The Monday she did not return home, so we knew something was wrong. Two friends of Coline informed us on the Tuesday that Coline died in the Athlone bomb blast. When we got to the mortuary my mother and I identified her body. Her face was full of blood, her eyes were out of her sockets. We then went into a room where our statements were taken. One policeman in this room asked me twice who I am and what am I doing there. He got quite upset about my presence and we found his behaviour very strange. The police told us that Coline died in a bomb blast. They described to us how it might have happened. Coline was sitting on her haunches, working with the explosives, Robert was standing behind her and that the explosives exploded in their faces. A few months later that year we recovered personal items of Coline. This included a pair of earrings, sanitary towels, a set of keys and torn clothes and a torn leather bag. What really put us in a puzzle, why did the sanitary towels come back and was not burnt. Another thought which struck us was that her nose was not damaged, only her eyes were out of their sockets. Were they tortured before their bodies exploded? Why would they plant a bomb at a public toilet? Were they arrested, tortured before the explosion? There was also a gun at the scene which they found under Robbie's body. Apparently the shop-owner heard gunshots before the explosion. As a family we have these questions.

That night there was nobody around there. People probably saw what happened and were too scared to come out. Robbie was also followed before the explosion. We do not believe the statement given by the police. Why was that policeman so disturbed by my presence.




