1. I act on behalf of AFORAT, twenty-six victims' Associates Families of the Rietbok Aircraft Tragedy who experienced apartheid era gross Human Rights Violations.

### Hearing schedule

2. On 10 September 2025, I provided you with our submission to the Commission on behalf of AFORAT.  
3. I understand that the Commission awaits notification of our intention to make an oral statement at this hearing and to hear from witnesses. It will then allocate a time for our group to participate.

Several witnesses have expressed worries in revealing too much personal information because over the six decades since with air crash, there have been death threats, coercion, and suppression of evidence with those involved in the investigation being sworn to absolute secrecy. This was part of the original questionable conduct.

Many of us consider that there are still threatening powers out there and we have been advised to redact out addresses, ID/Passport Numbers and work details.
