Declare under oath in English / confirm in English –

That:

I appeal to the Inquiry into TRC Stopped/Influenced Cases to examine and include the case of the Viscount Rietbok Flight SAA406 on 13 March 1967.

- **The state bodies failed the victims and their families at the time of the crash in 1967, again in 1968 at the formal Government Margo inquiry, in 1988 at the TRC and beyond.**
- **I call for a full investigation into why the crime-scene operatives were never held responsible. The crime-scene is STILL left unattended and is now under threat of being disturbed.**
- **I request transparency, full disclosures, and institutional accountability for this case. Attached is my full submission with background and context of the incident.**
- **I enclose documents submitted in 1998 to the TRC.**
- **A video copy of the meeting with families by the TRC representative Prof Janis Grobelaar is available.**

- A copy of the **Carte Blanche** TV program about the case is also available.
- After all the submissions, the TRC failed to respond, take calls or notify the victims' families group of the result of their application. Instead, they were simply left to discover the news on a radio announcement.
- I make an unwavering request for the matter to be investigated now.
- I submit a copy of:
 - o Original letters of submission to the TRC.
 - o Correspondence showing the TRC's failure to reply.
 - o Supporting documents gathered over the years.
- At this stage we have no answers as to why the case was not investigated according to standard procedures, why families were not told the truth, nor why the case was never prosecuted at the time and since.
- I seek:
 - o An explanation for non-investigation by the TRC and afterward.
 - o Formal reopening and state-supported investigation into this matter.
- I now live in Australia but because this case is so important to closure and the peace of mind for the rest of my life, to ease on the intergenerational effect trauma, I have made the journey to attend the 8 September pre-hearing out of my own pocket, as a retired senior citizen. I ask the Commission to please consider:
 - o Contributing toward these expenses.
 - o Accommodating my future participation via video links if in-person attendance isn't feasible.
 - o Virtual testimony can also be arranged.
