NOTICE OF MOTION

KINDLY TAKE NOTICE THAT the abovementioned Applicant intends making an application in the following terms:

1. That condonation be granted for the late filing of the Applicant’s affidavit in response to the Rule 3.3 Notice issued by the Commission on 14 October 2025;
2. That the Applicant be granted reasonable time to consult with the legal counsel appointed by the National Prosecuting Authority (“NPA”) to represent implicated officials, so that his submission may be properly aligned with the NPA’s coordinated legal position, avoid unnecessary duplication of effort, and assist the Commission by providing a coherent and comprehensive response;




3. That such affidavit be filed within 5 (five) business days of counsel's formal instruction;
4. That the Applicant's affidavit, when so filed, be accepted as properly before the Commission;
5. That the Applicant's rights in terms of Rules 3.3.6 and 3.4 of the Commission's Rules be noted and preserved, it being recorded that he intends, upon consultation with counsel, to apply for leave to (a) give evidence himself, (b) call witnesses in his defence, and (c) cross-examine the witness or witnesses whose evidence implicates him, and will submit the accompanying statement contemplated in Rule 3.4 once finalised;
6. Further and/or alternative relief.
