**SCHEDULE****TERMS OF REFERENCE****OF THE****JUDICIAL COMMISSION OF INQUIRY TO INQUIRE INTO ALLEGATIONS REGARDING EFFORTS OR ATTEMPTS HAVING BEEN MADE TO STOP THE INVESTIGATION OR PROSECUTION OF TRUTH AND RECONCILIATION COMMISSION CASES****Amendment of Terms of Reference**

1. The Terms of Reference of the Judicial Commission of Inquiry to inquire into allegations regarding efforts or attempts having been made to stop the investigation or prosecution of Truth and Reconciliation Commission cases as published in Proclamation No. 264 of 2025, is hereby amended by the substitution for paragraph 7 of the following paragraph:

- “7. The Commission must—
- 7.1 complete its work within the period commencing from 18 September 2025 and ending on 29 May 2026; and
  - 7.2 submit its report to the President within 60 days after the date on which the Commission completed its work.”.
